Proceedings of the Governing Council Meeting held on 13-07-2019 at 4.00 p.m in the Chambers of the Principal, P.E.S.College of Engineering, Mandya. Dr.H.D.Chowdaiah, Chairman, GC was in the chair.

At the outset, Dr.H.V.Ravindra, Principal and Secretary, Governing Council, extended a hearty welcome to the Hon'ble Chairman, and also to other Hon'ble Members, GC, who were present in the meeting. He also welcomed Dr.Ramalingaiah, who was invited to attend the meeting of Governing Council as a special invitee. The letter received from Dr.S.V.Ramaswamy, Hon'ble Member, Governing Council, expressing his inability to attend the GC meeting due to prior commitment was also read and recorded. It was resolved to confirm the same.

The following subjects as per the Agenda have been discussed and resolutions passed accordingly.

(1) Confirmation of the proceedings of the previous Governing Council Meeting held on 13-04-2019.

As there were no specific remarks from the Hon'ble Members regarding the proceedings of the previous Governing Council meeting held on 13.04.2019, it was resolved to confirm the same.

(2) Approval of action taken on the proceedings of the Governing Council Meeting held on 13-07-2019.

The action taken on the following subjects have been discussed in the meeting.

a) Regarding Power factor:

Dr.P.S.Puttaswamy, Professor (CAS) in Electrical and Electronics Engineering and special officer, Electrical, who was invited to the meeting submitted a comprehensive report after carrying out the maintenance work to improve the power factor. The Hon'ble August body expressed its satisfaction regarding the action taken so far. However, suggested for continuous monitoring for achieving the desired level.

b) Regarding the action taken for installation of Solar panels at the cost of the College itself:

The detailed report submitted by Sri. D.M. Srinivasa and Sri.B.N.Harisha, incharge of Solar installation, and who were also invited to the meeting presented a comprehensive report on the feasibility. After discussion, considering the cost factor involved for installation of solar panels at our own cost, and also the availability of additional space required for the solar installation, as we have reached the 80% of the sanctioned load 300KW, the Chairman, GC informed the August body to drop the idea due to the cost involvement.

c) Civil Works for improvement of infrastructure in various departments:

Dr.B.S.Jayashankarababu, Special Officer, Building division who was present at the time of the meeting explained the members regarding the work executed so far. He assured that the entire work will be completed before the commencement of the coming semester from 29.07.2019. However, Honbl'e Chairman expressed his concern regarding the civil works to be undertaken in the Environmental Engineering Department for occupation by the Civil Engg even after the lapse of 3 months after his visit of various departments. The special Officer informed the August body that he has received the proposal and drawings from the HOD of the Civil Engineering. Hon'ble, Chairman, GC instructed him to complete the work without any further loss of time.

(3) Consideration of the Audited Statement of Accounts for the period January -2019 to March-2019.

It was unanimously resolved to approve the audited statements of the accounts for the above period.

(4) Consideration of the Budget proposals for the financial year 2019-20.

The Budget proposal for the financial year 2019-20 was discussed. Honb'le member, Sri S.L. Shivaprasad sought the clarification from the Principal regarding the increase in the budget allotment towards power and light charges under aided courses in spite of installation of solar panels. Principal clarified that the increase in the budget allocation was taking into consideration of the additional buildings viz., the Guest house, Class room complex, Dr. H.D.Chowdaiah Auditorium, the hike in power tariff by KEB and also the charges being paid to the Renew Solar Energy Private Ltd. . Hence, it was resolved to approve the budget.

(5) Recruitment of Additional Teaching staff on permanent basis for Civil Engineering Department under Management (Unaided).

The subject was discussed at length. The reason for the publication of Employment Notification and also the subsequent changes approved by the Chairman, GC as per the request of the Head of the Department in respect of Structural Engineering was explained by the Principal to the August Body. Further, the August body resolved to approve the employment notification and also the subsequent changes made in the number of posts with respect to structural Engineering and also to go ahead with the recruitment procedure to fill up the posts of Asst. Professors in Civil Engineering under Management.

Additional Agenda

1) Sub: Obtaining Insurance policy from LIC of India for payment of Gratuity to Employees working in Unaided Departments.

The subject was discussed elaborately.

The Government has made it mandatory for the payment of Gratuity to 160 unaided employees after the retirement in proportion to their service as per Gratuity Act and Education Act of 1995. To be eligible for Gratuity the minimum service is 5 years with three months' pay and Maximum 30 years of service with 15 months pay (Basic + DA) of their last salary drawn with a maximum limit of Rs. 20.00 lakhs as per the prevailing Government Order

Dr.Ramalingaiah, Director, P.E.T.Institutions and Sri Ramesh Chandra Patnaik, Senior Branch Manager, Pension and Group Scheme, LIC of India, Mysore, who were invited by the Hon'ble Chairman, GC, participated in the deliberations. The Sr.Manager, LIC of India explained the benefits that can be derived for both employee and employer if the scheme is implemented.

After prolonged discussion, considering the benefits that would be ease out the financial burden on the Management down the road, Mr.Basavaiah, Hon'ble member, GC explained the August body that this scheme is best suited for implementation. The Hon'ble Chairman, GC, agreed to implement the proposal and informed the Principal that before going for agreement with LIC of India, it has to be discussed with the Hon'ble member Mr.Basavaiah, and Dr.Ramalingaiah, P.E.T. Director. He also informed the Principal to have a precise calculation of each individual member's liability among the 160 members who would be benefitted if the above scheme is implemented.
