1. Confirmation of the Eligibility process and selection of our college for TEQIP Phase-III

The Principal informed the TEQIP Co-ordinator to explain in detail about the selection process for eligibility for TEQIP Phase-III from April, 2017 and the step involved about the college selection for the Phase-III. TEQIP Co-ordinator, Dr. H V Ravindra narrated that the college had satisfied all the Performance Assessment Indicators (PAI) under TEQIP Phase-II that was specified by NPIU, New Delhi. Hence the college was selected under Sub Component 1.3 and also as a mentor institute for twinning arrangement with mentee institute for the total grant of Rs. 7.00 Crores. The mentee institute is Uma Nath Singh Institute of Engineering & Technology, VBS Purvanchal University, Jaunpur, Varanasi, UP. He also explained the implementation of twinning agreement signed with Mentee institute on 22/07/2017 at NPIU, New Delhi. Dr D.K.
